**PRE-SEEDING** - Make a copy of this form for every wrestler that may compete for your team in this year's tournament. This form must be filled out for any wrestler that you wish to consider for a seed. You may submit more than 10 wrestlers for the pre-seeding, but only 10 wrestlers per team are eligible to compete in the tournament. Each school may enter only one wrestler per weight.

**LINE-UP** - Fill in the names of ALL wrestlers that may represent your team in this year's tournament. It is essential that we receive the forms back no later than November 15, 2007 in order to expedite a fair seeding meeting for all teams.

**WEIGH-IN** - In accordance with the 2007 NCAA regulation we will be holding two weigh-ins for the tournament. The first weigh-in will take place on Friday, November 30<sup>th</sup> beginning at 7:00 a.m. The second weigh-in will be Saturday, December 1<sup>st</sup> beginning at 8:00 a.m. ALL TEAMS MUST WEIGH-IN AT THE TOURNAMENT SITE.

**DUAL MEETS** - This year we will be hosting several local Las Vegas High Schools dual meets starting at 4:00 pm Thursday, November 29, 2007. Universities that plan to wrestle dual meets on Thursday will need to complete and return the enclosed Dual Meet Participation Form. I will send your dual meet confirmation by Monday, November 19, 2007.
