Dear Coach:

The final arrangements have been made for the Twenty-Sixth Annual Cliff Keen Las Vegas Collegiate Wrestling Invitational, November 30 & December 1, 2007. This year's field will be comprised of entrants from approximately forty-five colleges and universities from all over the United States.

The site of this year's invitational will be at the Las Vegas Convention Center located in Las Vegas, Nevada. The host hotel is the Las Vegas Hilton conveniently located adjacent to the Las Vegas Convention Center.

Registration, weigh-in, and the wrestling tournament will take place at the Las Vegas Convention Center. I have a total of 300 rooms per night set aside for the tournament weekend at the Las Vegas Hilton. I am requiring that all teams participating in this year's tournament stay at Las Vegas Hilton. If you do not plan to have your team stay at the Las Vegas Hilton, you will need to contact me.

The room rates for this year are \$ 105.00 single/double. The room rate does not include the standard 9% Nevada room tax.

To make you're reservations contact Las Vegas Hilton directly. PLEASE MAKE YOUR ROOM RESERVATIONS AS SOON AS POSSIBLE. BE SURE TO TELL THE RESERVATION OPERATOR THAT YOU ARE WITH THE CLIFF KEEN COLLEGIATE WRESTLING INVITATIONAL.
