Dear Coach:

The final arrangements have been made for the Twenty Eighth Annual Cliff Keen Las Vegas Collegiate Wrestling Invitational, December 4<sup>th</sup> & 5<sup>th</sup> 2009. This year's field will be comprised of entrants from approximately forty-five colleges and universities from all over the United States.

The site of this year's invitational will be the Buffalo Bill's Resort Hotel / Star of the Desert Arena, located 40 miles south of Las Vegas at the California / Nevada Stateline. Registration, weigh-in, and the wrestling tournament will take place at the Star of the Desert Arena adjacent to the Buffalo Bill's Hotel.

I have a total of 300 rooms set aside for the tournament weekend at Buffalo Bill's, Whiskey Pete's and the Primadonna Hotels. I would request that all teams participating in this year's tournament stay at one of the aforementioned hotels.

The room rates are posted on the web site. The room rate does not include the standard 9% Nevada room tax. To make your reservations contact Primadonna Resorts directly.
